the Defendants, Euro Global Distribution, LLC., a Florida corporation (whose FEIN number is: 81-3599769), International Distribution Group, LLC, a Delaware corporation (whose FEIN number is: 27-2183682), Oliver Chauve (whose SSN is: XXX) and Christophe Brayer (whose SSN is: ██████████), jointly and severally, the sum of Forty-six thousand and Zero dollars and Zero cents (**\$46,000**) that shall bear interest at the legal rate of interest for which sum let execution issue.
